

2020 ANNUAL ASSEMBLY PRESIDENT'S REPORT

December 2, 2020

Dear Fellow Parishioners:

2020 has been an unusual year for our St. Luke Parish. On behalf of the Trusteeship, I have the following to report from our parish from the last year:

1. The beginning of 2020, started with great optimism and esprit de corps. Our parish was experiencing growth in church attendance, Stewardship and participation in activities and programs.

2. In January we joyously celebrated Christmas, had an exceptional St. Sava Akademija program and Slava celebration. Then in February we had a socially and financially successful Zurka event, which we hoped to repeat.

3. On March 2nd, we were blessed to have the presence of our beloved Patriarch +Irinej of blessed memory in our church to begin our Lenten journey. Following the Canon of St. Andrew, a special Patriarchal dinner was served. With a heavy heart, on November 20th, we prayed for the repose of our beloved Patriarch.

4. In mid-March, COVID-19 hit and had a major impact on our parish. We were forced to make a number of adjustments in our liturgical lives and how we interacted with each other in response to guidance we received from government and church authorities.

5. All communications and guidance received from governmental and diocesan authorities continue to be sent to all parishioners and friends via social media, email, and posted to our parish website.

6. Live streaming all liturgical and special services continues.

7. Father Vasilije conducts Zoom lectures on our faith and is available to minister to individual needs of parishioners.

8. The Parish Assistance Committee stands ready to help our parishioners get groceries, prescriptions, etc. It can be contacted by emailing <u>outreach@svluka.org</u> or contacting Father Vasilije.

9. To provide our parish with a financial cushion to cope with financial uncertainties brought on by the COVID-19 crisis and not knowing when it will end:

a. We applied for and received all financial assistance offered by the U.S. Small Business Administration to Faith Based Organizations. This will provide us with a financial cushion to cope with the financial uncertainties brought on by the COVID-19 crisis and not knowing when it will end.


b. At our request, the bank approved the deferment of principal and payment of interest only on our mortgage from May through July 2020, which reduced our monthly cash outflow by over \$3,000 for May, June, and July.

10. Due to COVID-19 restrictions, we were not able to hold our Serbian Food & Cultural Festival (SerbFest DC) in May and October of this year. This event fulfills valuable missions for our parish in terms of bringing awareness of our parish to within our local community and raising funds for the continued operation of our parish. We pray that we can resume in 2021.

11. We held a successful one-day, drive-through SerbFest in October.

12. One of the fellowship activities of our parish, serving lunch after Liturgy on Sundays was suspended, but a carryout lunch has been initiated. Please visitour parish store website at <u>https://svluka-store.square.site</u> for each week's menu and to place your order.

13. With the Blessing of His Grace +Bishop Irinej, there were changes to the Trusteeship Board as a result of shifting of positions. After more than 11 years as Secretary, Mark Stokrp will now serve as a Member-at-large, Milica Tasic will move from Financial Secretary to Secretary, and Maja Lojanica will move from

Member-at Large to Financial Secretary. Continuing, Mark Rasevic will serve as Vice President, John Buffalini as Treasurer and Pete Bizic, Predrag Djokic, and Alexander Terzic as Members-at-Large. I want to thank them all for their dedication and valuable contributions.

14. The committee structure that we implemented last year continues to provide more efficient board administration. Items are first vetted through the responsible committee and then brought before the board for final action or with interim updates. Those committees are: *Liturgical *Building & Grounds *Communications *Events Management *Loan & Finance *Strategic Planning *Bookstore *60th Anniversary *Volunteer Recruitment.

15. We commemorated all major Orthodox feast days – particularly the Feast of St. Sava and our St. Luke Slava.

16. The parish auxiliary groups – Kolo Srpskih Sestara, the Bratstvo, SSS "Lira", Parish Religious Education Program, Children's Choir, Folklore Group "Prelo," the Serbian School 'Nikola Tesla' and the Zmaj Youth Group – continue to do their good work to support the parish; the details of their activities are contained in separate reports (attached). I would like to thank all the auxiliary groups for their work in supporting our parish and representing our faith & culture in an exemplary fashion.

17. The parish e-mail distribution list keeps growing and continues to be the primary means of communication in the parish; e-mail distribution lists also continue to be used by the parish auxiliary groups. Social media has grown significantly as a means of communication as well.

18. The mailing list for the monthly donation envelopes underwent a major update.

19. All parish communications continue to be posted on the web site for access to all our parishioners.

20. Policies and procedures to ensure compliance with Article 26 of the Uniform Rules & Regulations of the Serbian Orthodox Church in North & South America which were drafted and implemented in January 2011, continue to be used.

21. A stewardship plan with annual pledges for the ongoing care and maintenance of our parish and facilities which was drafted and implemented in January 2011 continues to be used. A pledge form for 2021 is attached and everyone is encouraged to participate.


22. The importance of Stewardship cannot be over emphasized. It is a mechanism to show our commitment to this parish by pledging our financial support and sharing the talents that God has blessed us with by volunteering and participating on committees and projects.

23.Candle Business – through the initiative of Dejan Bujak, we continue the process of making our own beeswax candles, which is currently in limited production. A separate report is attached. We are hopeful that this business will create much-needed revenue for the parish. Thank you to Dejan Bujak and his team for all their work on this project.

24. After 6 years in our new parish facility, our parish continues to struggle to make ends meet financially. The parish leadership continues to explore ways to try and generate additional income and to control expenses, but the single most important source of financial support needs to come directly from our parishioners.

25.The Trusteeship is committed to ultimately moving this parish from a Trusteeship to an elected Board of Directors. Before this can happen, we must have the monthly funding gaps eliminated, build a financial reserve for contingencies and loan paydown and a continued increase in demonstrated support and commitment to this parish by its parishioners. Continued and increased participation in the life of our parish is vital to making this happen.

26.When the COVID-19 situation improves and parish life returns to pre-COVID conditions, I encourage all parishioners to participate in parish life as fully as possible as any community is only as strong as the level of participation in it. Come to church, bring your children to Sunday School, join one of our parish

Dear Brothers and Sisters in Christ,

To say 2020 was an unusual year is an understatement. As a parish community, we started 2020 very strong – argumentatively, it was the strongest we've ever started a year. We had record-breaking attendance for Christmas services, a highly successful St. Sava Celebration (Svetosavska Akademija), started a new tradition with our inaugural DC Zurka, and were blessed to be visited by His Holiness Patriarch +Irinej, now of blessed memory. All of these amazing things happened in a span of just nine weeks. Then, Covid-19 arrived and changed everything.

As Treasurer of the Trusteeship, it would be hypocritical for me to say that I wasn't nervous about how we would weather through this storm. However, with our faith in God, we as a community rallied together to pull through. And while we are not out of the woods by any means, thanks be to God, we are not in a horrible situation either.

Income:

Total income for the 2020 fiscal year was \$378,587.47. This is significantly lower than the income we received in fiscal year 2019. The difference is largely due to the income lost by not hosting our bi-annual SerbFest DC. Nevertheless, donation income continues to be our primary source of income.

Fiscal year 2020 income is broken down as follows:

•	Church Worship (Tasa/Candles/Bookstore):	\$199,629.34
•	Donations (In Memory/Building Fund/Slavas):	\$126,177.54
•	Social Events and Fundraisers:	\$52,780.59

Expenses:

Total expenses over fiscal year 2020 were \$312,094.35. This is significantly lower than the expenses we realized in fiscal year 2019. This was primarily driven by the relief measures discussed below and cancellation of our Spring and Fall SerbFest.

Our largest expenses for fiscal year 2020 were:

•	Mortgage Payments:	\$145,788.36
٠	Operational Expense	es: \$57,883.35

At the onset of Covid-19, the Trusteeship worked diligently to cut expenses wherever possible. Some cuts were temporary, while others are permanent.

Temporary relief measures include:

• Applying for and receiving funds from the Paycheck Protection Program – a Covid-19 relief program through the U.S. Government Small Business Association. These funds covered two months of

salary and benefits for Fr. Vasilije and are forgiveable, pending a successful application. This was a savings of over \$9,000.

- Working with our mortgage lender John Marshall Bank to pay a reduced mortgage payment for three months (May, June, July 2020). Rather than paying our full mortgage payment of \$13,041 each month, we paid only the principal. This resulted in a savings of over \$10,000.
- During the pandemic, while our facilities are not being used for anything other than liturgical services, we've cut back on our cleaning services. This is a savings of over \$400 each month.
- Receiving a one-time \$1,000 grant from the U.S. Small Business Association

Permanent relief measures include:

- Re-evaluating our Verizon phone/cable/internet services and cutting un-needed ancillary services from our package. This resulted in a savings of over \$250 per month.
- Adjusting our monthly donation envelope mailing list. This results in a savings of approximately \$120 per month.

While the Trusteeship was able to cut expenses and receive temporary Covid-19 relief measures, much of our expenses now are operational. Our Operational expenses keep our doors open to all of our parishioners and to the Washington Metropolitan Area community.

Trends and Reminders:

While the Trusteeship has taken many temporary and permanent measures to reduce expenses where possible, even in our leanest operational state, our monthly operational expenses are approximately \$25,000. When we return to full operational status (God-willingly, soon), our monthly operational expenses will increase. Given that our non-event-based donation income is approximately \$25,000 per month and considering the debt that still lingers on our books, we have work to do. While need to continue progress on closing our funding gap. In our current scenario, we cannot create a savings. We do not have a rainy-day fund.

I'd also like to remind everyone of an easy way to support our church – shopping on Amazon. I'm sure many of you have started using Amazon and other online services to shop during these times. If you are an Amazon customer, *Amazon Smile* is a great program to take advantage of. Instead of shopping by your regular Amazon link, simply change to smile.amazon.com and add *St. Luke Serbian Orthodox Church (Potomac, MD)* as your preferred charity. After your purchase, Amazon will donate 0.5% of your purchase amount to our church. It may not seem like a lot of money however, it adds up. In Fiscal Year 2020 we received \$528, which would be enough to cover three months' worth of gas bills.

In closing, 2020 would have been a different story if it weren't for two factors: 1) the aid we received from the Federal Government and our bank and 2) our parishioners continuing to support our parish during these trying times. I'd like to sincerely thank each and every one of our parishioners for their support of our parish. Your continued support enables us to keep our church open to serve the Serbian Orthodox faithful of our Nation's Capital.



2020 Candle Shop Report

(Dec 2020, by Dejan Bujak)

Introduction

Our candleshop is established and works under the auspices of the Diocese of Eastern America (Serbian Orthodox Church) and with the blessings of His Grace Bishop Irinej of Eastern America. We aim at providing a reliable supply of quality beeswax candles.

All profits are to benefit our St. Luke, Serbian Orthodox Church in Potomac, MD.

Until we are 100% ready to support all Eastern Diocese with the production, our only customer is our church (St. Luke). Once we are ready to support the Eastern Diocese, our plan is to hire a part-time or full-time person.

We are still struggling to have technology and process to be able to mass produce candles. Our hope that the new machine will be able to do that for us.

Taper-molding Machines

After more than a year of machines breaking, us fixing them we had to throw in a towel. Mainly since we found and purchased a better candle making machine (more about it later)

Candles made by dipping method

This is our main technology for making candles right now.

We'd love to figure out how to improve this technology and speed it up, please let us know if you're willing to help.

Extraction (New) Machine

This machine was made in Serbia. It makes candles by pushing a block of wax on one side and on the other comes out a candle, like a sausage or pasta process. With this machine: we can make any candle size (diameter and length)!

Since we just acquired the machine we still need to bring electricity to power it and fill it with hydraulic fluid and we'll be able to see how good it'll work.

To go with mass production, we need to find a good sistem to cut candles to size and release some wick at the top of candles so it can be lighted. Please let us know if you're willing to help

Looking for help

For tracking purposes below are tasks from previous year/s and new ones we still need to accomplish If you have experience in any of these please let us know.

- 1. Cooling process for taper-mold machines. Completed in 2020
 - a. Needed to connected hoses with quick release mechanisms to each machine.
 - b. Connect a pump to circulate cooling fluid through iced barrel
 - c. If above step produces good candles, purchase a chiller and equip it with quick release hoses, so the chiller can be switched between machines
- 2. Cleaning of frames for hand dipped candles.

After making hand dipped candles, metal frames have beeswax on them, that needs to be cleaned before new candles can be made. Right now, we put these frames in the melter (we can pack 8 frames at the time) and it takes about 2 hrs for the wax to melt. So, it takes 8 hrs to clean 30 frames. We're hoping we could either:

- a. Connect all frames together and heat them up within minutes to above 70F so wax can melt and fall off. Could this be done using electricity?
- b. Build new frames using materials that would allow for quick cleaning.
- 3. Improve our hand dipped wicking machine. Please ask and we can show you current design and suggested improvements.
- 4. We'll need somebody to help us figure out packing and shipping rates and set up a system for it.
- 5. We'll need a photographer and a web designer to build us a web site to sell candles.
- 6. If you can commit to regular volunteer hours for making candles please let us know.

Below is a list of other work we need help with:

1. Decorative candles. We could produce decorative candles which are much more profitable. If you have time to spearhead this effort please let us know.

- 2. We do recycle beeswax, we need help in turning out candles when they are close to the sand (if they get mixed with the sand very little to none can be recycled). Also, cleaning wax from the sand and melting it and getting it ready for production of new candles. We're also contemplating switching to containers with water instead of sand, so wax can be recycled much easier, help needed to design these containers and build them.
- 3. Need to weld some parts together, please let us know if you have welding experience.

Our Sunday School & Religious Education program provides an educational opportunity for our parish children to grow and learn in their faith. The curriculum that we provide to the students is ageappropriate and encourages them to think about how they can apply the teachings of the Church and the Bible to their daily lives.

2020 started out very well for the St Luke Sunday School & Religious Education Program, in late-January and early-February our students participated in the parish St Sava programs by reciting poems and presenting a reading on the life of St Sava. On March 1st, our students hosted the Cheesefare Sunday Luncheon and they did an amazing job preparing, serving, and cleaning up, with minimal help from their parents and their teachers. Sadly due to the pandemic, our last in person class session was held on Sunday, March 8th.

Our Sunday School & Religious Education program would not be successful if we didn't have the dedicated teachers that we have: John Buffalini (grades 8-12), Joyce Visnick (grades 5-7), Natalie Visnick (grades 3 & 4), and Desa Elwell (grades pre-K-2 grades), who continue to show their love of their church, their faith and the children with their well-prepared lessons. Both Joyce and Natalie graciously agreed to come back and teach in this unusual year.

It took some time to re-organize into a virtual learning environment, but we held our first virtual lessons on November 15, 2020; lessons will continue on a bi-weekly basis. The Club had a substantial interest in its first year with about 40 subscribers and on average 15 students in regular attendance.

St. Luke Serbian Orthodox Church Annual Audit Report

In accordance with the parish bylaws and Church constitution, an audit of the financial records for the St. Luke Serbian Orthodox Church of Potomac, MD, was performed virtually the week of 03 December 2020, due to the extraordinary circumstances created by the COVID-19 pandemic. The audit was performed by Marija Eremic and Mio Lazarevich, assisted by John Buffalini, Trusteeship Treasurer, by creating the .PDF files of the parish financial records. The reports provided to the audit team included the monthly bank records from United Bank and John Marshall bank, transaction details by month and event, major receipt copies, and answers to questions created as a result of our initial review. We performed the audit by reviewing the records for all months and associated receipts. We verified expenditures and gross receipts against the QuickBooks reports and found the receipts matched the summary records. All church expenditures were fully documented and substantiated with appropriate receipts, including the review of all checking/savings accounts for the various church functions, compliant with accounting rules and appropriately authorized by the Trusteeship Board, in accordance with bylaws. We very much appreciate the vast amount of work John put in to create the virtual records for the Audit team, which was very time consuming on his part, and know that his hard work should be commended to help mitigate the hardship caused by the current pandemic crisis.

Our review revealed that the overall income (credits) at the end of the year generally met or exceeded expenses (debits), and the ledgers were accurate in their accounting. We determined that the monthly collections combined with the special fund-raising events such as Christmas, St. Sava Celebration, and others exceeded expenses for the most part. There were difficulties in meeting our obligations during January 2020 and again the first few months of Pandemic crisis (March 2020 – May 2020), due to the timing of when bills were received versus when revenue was received (credit card bills coming on the heels of the full mortgage payment being made, creating a temporary cash flow problem), resulting in some minor late payment fees. Several actions were taken by the board to help mitigate further occurrence of this problem, to include working with Fr. Vasilije on applying for the COVID-19 Payroll Protection Program loan forgiveness program for two months, explaining the timing issue of mortgage and credit card bill payment (getting them to reverse the late charges as a result), and work with John Marshall Bank to defer principal payments on our loan for three months. In addition, the board has taken additional actions to reduce operating costs by adjusting our donation envelope costs by eliminating those envelopes for people no longer with the parish, and revising our telecommunications services so that our costs were cut by over 50%. We encourage all that do not do automatic donations to continue mailing in your donations while continuing your participation in the liturgy via streaming on Facebook.

We note that we still have to keep our eye on some longer-term expenses such as the frozen monthly Diocesan Assessment contributions by our Parish to the Diocese, and interest payments on loans made to us by our Parishioners, to ensure our obligations are accounted for in our annual budget projections and fundraising planning. The Board also applied for an Economic Injury Disaster Loan (EIDL), a program under the CARES Act, to provide a low interest loan (must be paid back), to cover expenses and hardships resulting from the Pandemic. We were approved for and received a loan in the amount of \$150,000.00, and is being held in a separate checking account until the board decides what we can potentially use these funds for. No action has been taken to date on the use of these funds.

Additionally, we reviewed the expenses of your Serbian School (Nikola Tesla), festivals and fund raisers, our Congregation's Religious Education School, and the Altar expenses, and found that these ministries and activities are self-sustaining, all with positive balances in their individual checking accounts.

We also reviewed the special events the Church Board had sponsored, such as Serb Fest, and Holiday celebrations such as St. Sava and St. Luke Slava, and other fellowship activities like the beer brewing workshop. We recommend that we continue these events as we can during this pandemic crisis, for both social and fund-raising reasons. These events have created much needed fellowship amongst the church community, and again are self-sustaining. We understand during this pandemic crisis, hosting such events are difficult, and pray that relief may come soon to sustain the positive spiritual, social and financial benefit that they provide to us.

As with all activities during the Pandemic, Sunday lunches were temporarily suspended. However, we are now starting this back up again, by making virtual orders for lunch and picking them up after Sunday Liturgy. We look forward to the time when the crisis turns the corner and we will be able to once again host in person lunches, and pray for your safety and health in the interim.

We also noted that in support of our outdoor liturgical services this summer, the Board made a minor investment of \$200.00 to improve the WiFi Signal from our communications system to boost the service to the outdoors, allowing more parishioners to watch services when we were outdoors. This investment was needed in any case whether serving outdoors or indoors, to improve this signal and help improve our streaming of the liturgy to our parish and beyond. We have received numerous thanks for the streaming services, so this was a well appreciated and inexpensive investment for the betterment of our community. We also wanted to recognize and thank Mr. Slobodan Droca and his firm for donating some new Audio-Visual equipment, and his time, to improve our streaming quality and reliability, as well as the audio distribution in the church, so that all can hear Fr. Vasilije as he prays for us during the liturgy.

Finally, we continue to encourage others in our greater Serbian community to join in and pledge support to help the St. Luke Serbian Orthodox Church grow to meet their collective spiritual needs and our faith. Call your Orthodox friends and family to join us to help build a stronger and larger worship community.
